
Cookie Policy

This website uses Cookies to improve and optimize the user's experience. Below you will find detailed information regarding these Cookies: what they are, what types of Cookies are used on this website, how to deactivate the Cookies, and specifically how to block the installation of Cookies from a third party site.

What are Cookies?

Cookies are files that websites or applications install in the browser or in the device (Smartphone, Tablet, or connected television) of the user during the webpage searches or throughout the application, and they are used to store information about the visited sites.

Similar to the other internet sites, this website uses Cookies for the following reasons:

- To make sure that the web page functions correctly.
- To store the preferences, such as the selected language or the selected font.
- To determine the user's navigation experience.
- To gather anonymous statistical information, such as what pages were visited by the user or how long the user has spent on each website.

Informational Note. - The above represent the usual uses of cookies. If you should wish to incorporate or remove any of them due to a specific and justified reason, they can be easily modified.

The use of Cookies permits the navigation by adapting the information and the services offered according to the user's interests to provide better experience each time the website is visited.

This website uses Cookies to function, adapt, and to facilitate the user's navigation.

Classification,
purpose, and
operation

Cookies, in function of their permanence, can be classified as session cookies or persistent cookies. The session cookies expire when the user closes the browser. The persistent cookies expire when the objective for which they serve has been achieved (for example so that the user remains identified on the website) or when the cookies are erased manually.

Additionally, and depending on the objectives, Cookies can be classified according to the following forms:

Strictly necessary (technical): These Cookies are essential for the correct functioning of the page. Normally, they are created when the User accesses a website or begins a session on the same website, and the cookies are used to identify the user on the website with the following reasons in mind:

- To save the identification of the User so that, if he/she leaves the website, browser, or the device and wishes to return at a later time, he will continue to be identified, therefore facilitating his navigation without having to identify himself / herself again.
- To verify that the User is authorized to access certain services or areas on the website.

Performance: The cookies are used to improve the navigation experience and optimize the functioning of the website. For example, saving the service configurations or saving the purchase that has been placed in a shopping cart.

Publicity: These are cookies that collect information about the announcements shown to users on the website. They can be of two types:

- Anonymous: They only collect information about the publicity shown on the website, regardless of the users who access the site, that is, without specifically identifying the user.
- Personalized: They collect personal information about the website users by means of a third party, for the purpose of personalizing the aforementioned publicity.

Geolocation: These Cookies are used to gain information regarding the country or region where the user is located when said user accesses a website service for the purpose of offering the user contents or services that have been modified according to his/her location.

Of analyses: These cookies gather information regarding the navigation experience of the user on the website. Normally anonymously, although they may on occasion permit the site to identify the user uniquely and unequivocally with the objective of obtaining information regarding the users' interests about the services offered on the website.

Cookies used on this website

See the table below for a complete listing of all the Cookies used on this website, incorporating an "intrusion level" based on a scale from 1 to 3, in which:

Level 1: corresponds to the Cookies that are strictly necessary for providing the service requested by the user.

Level 2: corresponds with Performance Cookies (anonymous) that are necessary for the servicing of contents and navigation. The user must only be informed of the existence of these Cookies.

Level 3: Correspond to the Cookies managed by third parties that enable the monitoring of the user by means of webs that do not belong to FESTIVAL FIB, AIE.

Normally, these correspond to Cookies of publicity or analyses where the user is identified uniquely and evidently.

Google Analytics

If the Cookies are disabled from this website, it is possible that you will not be able to access some areas of the website or that some parts of the site may not work properly.

Additional guarantees and withdrawal of the acceptance

As an additional guarantee, the Cookies registration on this site is subject to the Cookie Acceptance by the user during his/her visit to the website, the installation that has not been updated on the browser, and this acceptance can be withdrawn at any time in the options of content and privacy configuration available as mentioned before in the point 4 of this Cookie Policy.
